As per the notification, Previously, EPFO introduced an online facility for submitting Applications for Validation of Option/Joint Options for pension on higher wages. In response to requests from Employers and Employers' Associations for an extension of the time period to upload wage details of applicant pensioners/members, EPFO has decided to extend the deadline. As of September 29, 2023, there are 5.52 lakh pending Applications for Validation of Option/Joint Options with employers. The Chairman of the Central Board of Trustees has sympathetically considered this



request and extended the time for employers to submit wage details until December 31, 2023. Please refer to the notification for more details.



EPFO Issues Guidelines for Standard Operating Procedure for Inspection of **Establishments**

Vide Circular No: CAIU/SOP/2022/40

As per the notification, The Employees' Provident Fund Organization (EPFO) has issued guidelines in continuation of the Standard Operating Procedure for the inspection of establishments as outlined in Circular, Under these guidelines, all field offices of EPFO are required to conduct a Desk Review of all establishments (not marked as "closed") at least once a year. If, after the Desk Review, a physical inspection is deemed necessary, the Regional/District Office will notify the establishment, and a satisfactory response must be provided. Failure to do so will result in a request for a Physical Inspection being uploaded onto the CAIU Portal. Establishments that have reported closure and provided all relevant information will be marked as "closed" in the Unified Portal as per the guidelines. EPFO Issues New Process for Updating EPF Accounts' Information

Vide Notification No: WSU/2022/Rationalisation of work areas/Joint Declaration / 284

As per the notification, The new Standard Operating Procedure (SOP) from EPFO allows EPF members to update 11 profile-related parameters, including name, gender, date of birth, father's name, relationship, marital status, date of joining, reason for leaving, date of leaving, nationality, and Aadhaar numbertives. Governor of West Bengal Issues Guidelines for Payment of Bonus

Vide Notification No: Labr./853/(LC-IR)/222013/56/2019

As per the notification, The Governor of West Bengal has issued an appeal to all employers and employees in the state covered under the Payment of Bonus Act, 1965 (as amended by the Payment of Bonus (Amendment) Act, 2015). These guidelines are intended to ensure that legitimate dues of workers in respect of payment of bonus are set in view of the upcoming Durga Puja for the year 2023.

Punjab Government Issues Notification Regarding Exemption from Provisions of the Factories Act, 1948

Vide Notification No: E-517838-943

As per the notification, The Government of Punjab has issued a notification granting exemption to all factories from the provisions of sections 51, 52, 54, and 56 of the Factories Act, 1948, until further orders. This exemption is subject to the following conditions:

- The total number of hours of work in any day shall not exceed twelve.
- The spread-over, inclusive of intervals for rest, shall not exceed thirteen hours in any one day. For more information, please refer to the attached notification.
- ESI Announces Coverage for Casual and Contractual Employees of Municipal Bodies

Upon the issuance of notifications for ESI coverage by the respective States/UTs, casual and contractual workers employed by municipal bodies will be eligible to avail of the full range of benefits available under the ESI Act. These benefits include sickness benefits, maternity benefits, disablement benefits, dependent's benefits, funeral expenses, etc. Furthermore, these workers will have access to medical services through a vast network of ESI facilities, comprising 160 hospitals and over 1500 dispensaries across the country.



Extension of Time Limit for Atal Beemit Vyakti Kalyan Yojana

Vide Notification No: (N-12011/01/2023-P&D),

As per the notification, The ESIC has extended the Atal Beemit Vyakti Kalyan Yojana from July 1, 2022, to June 30, 2024, with improvements in the rate of relief and eligibility conditions. Please refer to the notification for more details.







Permission to Keep Establishments Open Year-Round in Telangana

Vide Notification No: 12

As per the notification, The Government of Telangana has published a notification allowing all establishments under the Telangana Shops and Establishments Act, 1988, to remain open year-round for a further period of three years, starting from June 16, 2022, subject to prescribed conditions.



Rajasthan PCB Issues Revised Checklist for Consent to Establish / Operate / Authorization / Registration

Vide Notification No: F.14.(5-Adm)RSPCB/Project | 2so-)3

As per the notification, The Rajasthan State Pollution Control Board, through an office order dated October 20, 2021, has issued a revised checklist of documents required to obtain consent to establish / operate / authorize / register under the E-Waste Management Rules, 2016, Bio-medical Waste Management Rules, 2016, and Hazardous and Other Waste (Management and Trans-boundary Movement) Rules, 2016.

As per the notification, The state government of Tamil Nadu has revised the minimum wage rates for employment in paper and other incidental processes connected with the machine-made paper industry under the provisions of the Minimum Wages Act, 1948.

As per the notification, The Government of India has released minimum wages for various categories, including construction or maintenance of roads or runways and building operations. These rates are effective from October 1, 2023. Please refer to the order for more details.
