Exemption notification under the Shops and Establishment Act in Chandigarh

Vide Memo No. 12/2/149-HII (2)/2024/9789, dated 25.06.2024

As per the notification, the Chandigarh is pleased to exempt all shops and commercial establishments registered under this Act in the Union Territory, Chandigarh from the operation of provisions of Section 9, Sub-Section-(1) of Section 10 and section 30 of the said Act subject to the mentioned conditions in the notification. Vide Circular No: E-File No: 763539/1902 dated 21.06.2024.

As per the circular, the EPFO has issued Web circulation for Assistance to members/beneficiaries in filling pension claims at PRO section. Since PRO is the interface between the field office and its member/ Beneficiaries, its role in guiding and educating members/ beneficiaries is of utmost importance. 

Circular on modification in table b under eps 95 for the purpose of calculation of past service benefit in EPF

Vide File No: e-37633/1921 dated 24.06.2024

As per the circular, EPFO has released Circular regarding the modification in Table B under EPS 95 for the purpose of calculation of past service benefit under Para 12(3) (i) (b) of the Scheme service benefit in EPF. The Ministry of Labour and Employment, GOI has extended Table B under Employees Pension Scheme' 1995 and laid down the corresponding factor for calculation of past service benefit under Para 12 (3) (i) (b) accounting for period further up to 42 years. Circular on modification in table d under eps 95 for the purpose of calculation of withdrawal benefit in EPF

Vide File No: e-37633/1920 dated 24.06.2024.

As per the circular, EPFO has released Circular regarding the modification in Table D under EPS'95 which is used for the calculation of withdrawal benefit in terms of Para 14 of the Scheme. Instead of taking the number of years of service as the basis of calculation, henceforth in cases not illegible for pension, the completed months of contributory service shall take into account for the calculation of the withdrawal benefits. The revised Table D is applicable for all withdrawal benefit cases settled after the date of notification, irrespective of the date of leaving services, in accordance with Para 6Aof the scheme. Circular regarding time barred claim relaxation in RO ESI beneficiaries

Vide Circular No: U-16/12/1/Misc./2023/Delhi/Time Barred(E-345640) dated 24.06.2024.

As per the Circular, with reference to this office letter No. U-16/51/7/2013-Med. III dated March 19, 2014. In the above-mentioned letter, all concerned were requested to decide to create awareness among the ESI beneficiaries in order to avail timely reimbursement and that such cases of time barred reimbursement claim as reason for the delay due to IP non-awareness will not be considered after March 31, 2014. However, it has been observed that such cases of time-barred medical reimbursement claim in r/o ESI beneficiaries are still being forwarded to Hqrs. Office. Notification of the rights of persons with disabilities amendment rules 2024

Vide Notification No: G.S.R. 343(E) dated 20.06.2024.

As per the notification, the Ministry of Social Justice and Empowerment and Department of Empowerment of Persons with Disabilities (Divyangjan) has released the Rights of Persons with Disabilities Rules, 2017, in rule 15, in sub-rule (1), after clause (m), the following clause shall be inserted, namely:-"(n) Accessibility Code for Educational Institutions as specified, in the notification of the Department of School Education and Literacy, Ministry of Education, Government of India vide notification number F. No. 9-4/2022-IS.18 dated 10th January, 2024". For further information, kindly refer to Notification.

Circular issued regarding decriminalisation of certain acts Punjab Shop Act

Vide Notification No: 07/25/2023-4AR dated 02.07.2024

As per the notification, the Government of Haryana has issued circular on decriminalisation of certain Acts (The Punjab shops and commercial Establishments Act, 1956). Details of the Acts as per following: (a) Not to be decriminalised (b) Already decriminalised (c) Proposed to be decriminalised with a tentative timeline. Gujarat laws amendment of provisions ordinance 2024

Vide Ordinance No: 1 dated 01.07.2024

As per the notification, the government of Gujarat issued the Gujarat Laws (Amendment of Provisions) Ordinance, 2024 to further amend the provisions of the Act made by the State of Gujarat to give effect to the references to Bharatiya Nyaya Sanhita, 2023, the Bharatiya Sakshya Adhiniyam, 2023. The following has been stated namely:- 1. The list of laws amended is stated in the notification, this shall have effect subject to the specified amendments. 2. The newly re-enacted Acts shall come into force with effect from July 01, 2024. For further information, kindly refer to Notification.



Clarification regarding correction in date of birth of insured persons and their family members dependents in ESI

Vide Notification No: N-12013/2/2023-BFT-II, dated 02/07/2024

As per the notification, the Employees State Insurance, clarified that that any correction / updation in the Date of Birth of insured persons and their family members / dependents be made in accordance with the provisions outlined in Reg. 80 (2) of the ESI (General) Regulation, 1950 and Para 1.73 of ESIC Branch Office Manual. Hence, all ROs / SROs are requested to bring the above instructions to the notice of subordinate offices and staffs for compliance. Circular on standard operating procedure on freezing and De freezing the MID UAN and Establishment under EPF

Vide Notification No: FIA/11(22)/SOP/Freezing UAN/2022 (E-49005)/3106 dated 04.07.2024

As per the notification, the Employee Provident Fund Organisation, has issued deployment of functionality for the Standard Operating Procedure (SOP) on Freezing/Defreezing the MID/UAN/Establishment. It states that this SOP aims to provide a time-bound methodology for freezing MIDs/UANS/Establishments on account of verifications requirements, as a measure of due diligence to secure the funds in these MID/UANs/Establishments and the subsequent de-freezing, wherever required, on completion of verification of genuineness. Circular regarding Facial authentication technology FAT promotion campaign

Vide Notification No: Pension/FAT-Publicity/2023/3417

As per the notification, Employee Provident Fund Organisation has targeted Promotion campaign is being launched to increase adoption of FAT for submission of Digital Life Certificate (DLC). This will in the long run, reduce dependence of the pensioners on banks and other intermediaries for updation of DLCs. Mentioned action to be taken, 1. Involve Pension Disbursing Banks, 2. Information Dissemination to Employers/Unions, 3. SMS to Pensioners, 4. Dealing with cases where a physical life certification has been received previously, 5. A Handout on DLC submission through Face Authentication Technology (FAT), 6. Pensioners visiting the office for DLC. For further information, kindly refer to Notification.

Circular regarding SOP for management of regulation of EPF Exempted Establishments

Vide File No: E-III/10(116)2023/SOP-Management and Regulation-Part(1)/6102 dated 11.06.2024

As per the notification, the employee provident fund organisation had issued an SOP for Management and Regulation of EPF Exempted Establishments, in which EPFO had communicated that Form-5, and Form RM-6, i.e., the Balance Sheet of the Trust Fund and the Format of the Third-Party Audit, were under preparation and would be issued separately. Now, in pursuant to the above circular, the EPFO has finalized Form- RM-6 (Format of Third-Party Audit), and has published the same through its circular no. E-III/10(116)2023/SOP-Management and Regulation-Part(1)/6102, dated 11th July 2024. For further information, kindly refer to Notification.

Employer to obtain valid insurance policy before six months under the Karnataka compulsory Gratuity Insurance Rules 2024

Vide Notification No: LD 325 LET 2023, dated 04/07/2024

As per the notification, The Government of Karnataka has issued a corrigendum extending the timeline for obtaining a valid insurance policy by the exiting establishments for their liability towards payment of gratuity to all eligible employees under the Payment of Gratuity Act, 1972. Now, the valid insurance policy is required to be obtained within 10th July 2024 i.e., six months from the date of commencement of the Karnataka Compulsory Gratuity Insurance Rules, 2024. Vide Notification No: 271442/104 dated 02/07/2024.

As per the notification, the Assam Private Placement Agencies for Recruitment of Workers (Regulation) Act, 2019, the Government of Assam issued and notified the Assam Private Placement Agencies for Recruitment of Workers Regulation Rules, 2024 ("Rules"). The Rules, reflect an effort to regulate the private placement agencies and safeguard workers' rights in Assam. With the introduction of the Rules, the Government of Assam aims to enhance transparency, accountability, and regulate the operation of such private placement agencies. Notification regarding coverage of ESI Scheme to six districts of Manipur

Vide S.O. 2696(E) dated 10/07/2024

As per the Notification, Employees' State Insurance Act, 1948 (34 of 1948), the Central Government hereby appoints the 1st day of August, 2024, as the date on which the provisions of sections 38 to 43 (both inclusive), sections 45A, 45AA, 45B, 45C, 45D, 45E, 45F, 45G, 45H and 45I, sections 46 to 73(both inclusive), section 74 and section 75, sub-section (2) to (4) of section 76, section 82 and section 83 of the said Act shall come into force in all the areas of Bishnupur, Senapati, Ukhrul, Kangpokpi, Churachandpur and Thoubal districts in the State of Manipur.
