#### Circular regarding removal of mandatory uploading of the image of cheque leaf attested bank passbook for certain eligible cases in EPF claim.

### Vide Circular No: WSU/E-49885 dated 28.05.2024.

As per the circular, the Employee Provident Fund Organisation, with view to facilitate the speedy settlement of claims filed online and reduce the rejection of claims due to the reason of non-up-loading of the image of cheque leaf/attested bank passbook while filing claims online, it has been decided with the approval of the CPFC to relax the requirement of mandatory uploading of the image of cheque leaf/attested bank passbook for certain eligible cases based on certain validation which include online verification of the Bank KYC by concerned Bank/NPCI, verification of Bank KYC by the employer using DSC, Seeded Adhaar Number verified by UIDAI among others. As per the Circular, the Ministry of Labour and Employment directed to refer to EPFO's UO Note No: INV-11/2/2021-INV/155 dated 20.03.2024 on the subject mentioned above and to hereby convey the approval of the Central Government under Para 60(1) of the Employees' Provident Funds Scheme, 1952 for crediting of interest @ 8.25% on EPF accumulations for the financial year 2023-2024 to the account of each member of the Scheme. # Exemption to all information technology enabled services ITES and Information Technology Establishments act Telangana state

As per the notification, the Telangana government has extended the exemption provided to IT and IT-enabled services establishments in the state from certain provisions of the Telangana Shops and Establishments Act, 1988, for a further period of four years with effect from May 30, 2024. # Circular on discontinuation of covid-19 advances under para 68l of EPS scheme grant of advances in abnormal conditions

#### Vide Circular No: F. No. I-21013/1/2022/ICT-Part-I, dated 13.06.2024.

As per the circular, the Employee State Insurance Corporation, the reference is made to this office letter of even No. dated 08-01-2024 and subsequent correspondence from the Benefit Division concerning the necessity for seeding of Aadhaar for Insured Person (Ips), ESIC employees, and Pensioners. In line facilitating the seamless process of Aadhaar seeding for Ips and their family members, ICT division has devised the provisions in IP Portal, Employer Portal, ESIC Staff and "AAA+" Mobile App. For further information, kindly refer to Circular.







### The Employees provident funds amendment scheme 2024

#### Vide Notification No: G.S.R. 329 (E) dated 14.06.2024.

As per the notification, the Employees' Provident Funds Scheme, 1952, in paragraph 32A, for sub-paragraph (1), the following sub-paragraph shall be substituted, namely:-"(1) Where an employer makes default in the payment of any contribution to the fund, or in the transfer of accumulations required to be transferred by him under sub-section (2) of section 15 or sub-section (5) of section 17 of the Act or in the payment of any charges payable under any other provisions of the Act or Scheme or under any of the conditions specified under section 17 of the Act, the Central Provident Fund Commissioner or such officer as may be authorised by the Central Government by notification in the Official Gazette in this behalf, may recover damages from the employer at the rate of one per cent. of the arrear of contribution per month or part thereof. #### The Employees' Pension Amendment Scheme 2024

#### Vide Notification No: G.S.R. 325 (E) dated 14.06.2024.

As per the Notification, in the Employees' Pension Scheme, 1995, in the 'Table B'(See Paragraphs 12 and 14) (FACTOR FOR COMPUTATION OF PAST SERVICE BENEFIT UNDER THE CEASED FAMILY PENSION SCHEME FOR EXISTING MEMBERS ON EXIT FROM THE EMPLOYMENT), after the entry "less than 34" in column (1) and the corresponding entry "13.173" in column (2), the data shall be inserted as mentioned in the notification. 


## The employees deposit linked Insurance amendment Scheme 2024

#### Vide Notification No: G.S.R. 330 (E) dated 14.06.2024.

As per the e Employees' Deposit Linked Insurance Scheme, 1976, in paragraph 8A, for sub-paragraph (1), the following sub-paragraph shall be substituted, namely:- "(1) Where an employer makes default in the payment of any contribution to the Insurance Fund, or in the payment of any charges payable under any other provisions of the Act or the Scheme, the Central Provident Fund Commissioner or such officer as may be authorised by the Central Government by notification in the Official Gazette in this behalf, may recover damages from the employer at the rate of one per cent. of the arrear of contribution per month or part thereof. #### Vide Notification No: BSKMM-2024-1545, dated 14.06.2024.

As per the notification, in a significant move towards inclusivity, the Madhya Pradesh Building and Other Construction Workers Welfare Board has launched the "Building and Other Construction Disability Assistance Grant Scheme, 2024." Effective April 1, 2023, this scheme aims to assist disabled construction workers by providing grants for essential equipment such as motorized tricycles. Eligibility hinges on possessing a Unique Disability ID (UDID) with a disability of 40% or more, along with valid identity cards and registration with the Board. # Exemption for employment of women during night shift in Rajasthan

#### Vide Notification No: F14(11)(1) Labour/law/2017/4863607 dated 20.06.2024

As per the Notification, the Labour Department of Rajasthan issued a notification on 19th March 2024 regarding decisions made under the Industrial Disputes Act. The notification grants certain exemptions to shops and commercial establishments registered under the Rajasthan Shops and Commercial Institutions Act for a period of three years. These exemptions are subject to specific conditions aimed at ensuring the safety and well-being of female employees, particularly those working during night hours. The conditions include obtaining consent from female employees for night-time work, providing necessary safety measures for travel and workplace environment, issuing employment letters and identity cards, offering restrooms and lockers for women workers, and implementing measures to prevent sexual harassment. The notification also outlines the automatic termination of exemptions and the liability of employers in case of violation of the specified conditions. As per the notification, the Rajasthan Government issued notification dated 02nd May, 2024, specifically focusing on the decisions given under the Industrial Disputes Act by the Labour Department. The notification pertains to the Rajasthan Shops and Commercial Establishments Act, 1958. It grants certain exemptions and provisions to the shops and commercial establishments registered under the Act. These provisions include granting employees one day off per week on a rotation basis, limiting the daily and weekly working hours, ensuring payment of wages as per the Payment of Wages Act, providing appointment letters to all employees, and stipulating that the exemption applies to shops and commercial establishments under all sections of the Employees Act. #### Extension of medical benefits to insured persons families in Uttarakhand

#### Vide Notification No: N-17011/1/UK/2024-P&D dated 18.06.2024.

As per the Notification, Employees' State Insurance Act, 1948 (34 of 1948), read with Regulation 95-A of the Employees' State Insurance (General) Regulations, 1950, the Director General has fixed the 1 st April, 2024 as the date from, which the medical benefit as laid down in the said Regulation 95-A shall be extended to the families of insured persons in all the areas of districts namely (1) Almora (2) Bageshwar (3) Chamoli (4) Champawat (5) Pithoragarh (6) Rudraprayag (7) Uttarkashi in the state of Uttarakhand. #### Mandate to publish on online dashboard in public domain under EODB

#### Vide Notification G.O. RT. NO. 340, dated 21.06.2024.

As per the Notification the government of Telangana hereby instructed the Director of Labour, Director of Factories and Director of Boilers to develop and implement the dashboard in their respective websites covering the following features, in terms of reform no.167 communicated by the EODB Team of Industries department. Mandate to publish an online dashboard in public domain with following features i. Clearly publish the data on number of applications received and granted, and the time taken and fee incurred to grant approvals/certificate ii. Highlight that the dashboard is updated preferably on real time or updated regularly (daily/weekly/fortnightly/monthly). Date and time of modification may be mentioned. ## The Gujarat private security agencies regulations rules 2024

In exercise of the power conferred by sub-section (1) of section 25 read with section 11 of the Private Security Agencies (Regulation) Act, 2005 (29 of 2005) and in supersession of the Gujarat Private Security Agencies Rules, 2007, except as respects things done or omitted to be done before such supersession, the Government of Gujarat, hereby makes the rules namely Gujarat Private Security Agencies (Regulations) Rules, 2024. #### The rights of person with disabilities amendment rules 2024

#### Vide Notification No: G.S.R. 334(E) dated 22.03.2024.

As per the Notification, MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT, in exercise of the powers conferred by sub-sections (1) and (2) of section 100 of the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the Central Government hereby makes the rules further to amend the Rights of Persons with Disabilities Rules, 2017. These rules may be called the Rights of Persons with Disabilities (Amendment) Rules, 2024. n the Rights of Persons with Disabilities Rules, 2017, in rule 15, in sub-rule (1), after clause ( $\ell$ ), the following clause shall be inserted, "(m) Accessibility Standards and Guidelines for MHA Specific Built Infrastructures & Associated Services for Police Stations, Prisons & Disaster Mitigation Centres, as specified in the notification of the Ministry of Home Affairs, Government of India vide notification number F.
